SUMMARY REPORT

Application from 1 January 2025 of the obligation for vehicles currently equipped with an analogue or digital non-smart tachograph operating in Member States other than their Member State of registration to be fitted with a smart tachograph version 2 (Article 3(4) of Regulation (EU) No 165/2014).

Following a discussion in the Committee, a consensus was reached among Member States for a period of 2 months of *educational learning period* on the retrofit obligation provision for vehicles operating in Member States other than their Member State of registration and currently equipped with an analogue or digital non-smart tachograph, to be equipped with a smart tachograph version 2 by 31 December 2024, until 28 February 2025.

This means that until 28 February 2025, enforcement would be focused on continuing to raise awareness of this obligation, instead of applying a sanction or penalty at the roadside, for those operators which, for various reasons, may not yet have managed to undertake the tachograph retrofit.

MOVE invited Member States to share with MOVE any publication of national administrative implementation of this approach as well as the way operators would be informed (for instance publication on a relevant website).
